1.0 History of the Faculty of Business Studies

The historical backdrop of Vavuniya Campus as a seat of learning returns to 1991 as it was framed by raising the status of the NPAUC. The Students of the NPAUC were retained into the Vavuniya Campus of the University of Jaffna, and the Faculty started its scholastic activities in 1997. The first direct intake to the Campus took place in 1998, and the students from the Commerce and Arts streams were admitted to the Management course for the academic year 1997/1998.

Faculty of Business Studies consists of three Departments, namely, the Department of Finance and Accountancy, the Department of Economics and Management, and the Department of English Language Teaching. In the Faculty of Business Studies, initially, a three-year Bachelor of Business Administration (BBA) degree was offered, and, now, both three and four-year Bachelor of Business Management (BBM) degrees are offered for students.

The Faculty offers a Bachelor of Business Management (BBM) honours degree programme in Accounting and Finance, Marketing Management, Business Economics, and Human Resource Management. Further, the Faculty introduced a new degree programme in BBM in Project Management (BBM in PM), which commenced from the academic year 2014/15. The degree programme was upgraded as honours degree in Project Management from the Academic Year 2017/2018. The Faculty's present student population is 650.

Our programme emphasizes practical and theoretical knowledge in the fields of Accounting, Finance, Economics, Human Resource Management, Marketing, and Project Management. It provides a good foundation for the undergraduates to qualify and compete in professional examinations, inculcate positive attitudes, ingenuity, and self confidence.





5.0 New Projects / Programs

5.1 Establishing Center for Project Management Under KOICA Grant Assistance

The Faculty of Business studies is the pioneer in Project Management undergraduate degree programs. This is the only Faculty in Sri Lanka that offers Project Management degree programs to the undergraduates. The Faculty of Business Studies took the initiative to establish the Center for Project Management, and the Concept paper for it was submitted to the Ministry of Higher Educations for seeking the financial support under KOICA Grant Assistance 2020. The main objective of the project is to develop the capacities of human resources required for the project management landscape in multifaceted projects in all areas of business, industry and public administration in Sri Lanka.

5.2 Developing the Curriculum for Tourism and Hospitality Management

Since the tourism and hospitality industry significantly contributes to the GDP of the nation, the Faculty of Business Studies has planned to initiate a unique degree programme in this area. A committee for developing the curriculum for this programme and the budget were set and approved by the Council. Discussions are going on with experts to produce a curriculum tailored to fit the needs of the industry.

5.3 Introducing New Honours Undergraduate Degree Programmes

The Faculty expects to admit students from the Academic Year 2021/2022 onwards for the following degree programmes namely; Banking and Insurance, Entrepreneurship, and Business Information Systems.

5.4 Master Degree Programmes

It was initiated by the Faculty Board at its 177th meeting held on 28th February 2020 to develop a curriculum for the Master of Business Administration (MBA) and Master of Project Management (MPM). The committee members were appointed and the curriculum development is in progress.

5.5 Establishing New Departments

The formation of five departments is under approval in the University Grants Commission (UGC) and are as follows: Department of Business Economics, Department of Marketing Management, Department of Human Resource Management, Department of Project Management, and Department of Entrepreneurship and Management. The Faculty expects the establishment of departments to be gazetted in early 2021 to start the activities formally.

6.0 Memorandum of Understanding (MoU)





CIPM Sri Lanka and the Department of Economics and Management of the Faculty of Business Studies entered into an MoU for facilitating academic co-operation, knowledge exchange, and capacity building to develop competent human resource professionals to serve the economy of Sri Lanka. students and has continued online lectures for the first and second year students. During this period, the Faculty's academic activities were carried out whole the week.

9.8 The Launch of the First Newsletter of the Faculty of Business Studies





12.0 Future Plans

The Faculty of Business Studies is intended to achieve the following as specified in the Strategic Plan 2021 - 2025. The progress is as summarized below;

1. Signing MOUs with Professional bodies: CIPM, SLIM, PMI, IPS, CMA.

Initiatives have already been taken by the Faculty officials to sign MOUs with Professional bodies. The Faculty has entered into MOUs with SLIM and CIPM already and progressing towards signing MOUs with Institute of Policy Studies and Project Management Institute paving the way towards a win-win situation.

- 2. Faculty business incubator cell project writing is in progress.
- 3. Establishment of five new student clubs are in process.

The Faculty has recognized that the students' learning should not merely be directed towards classroom learning. It is of utmost importance to strengthen energies for the complete transformation of the students. The Council has already approved the formation of the Economics Club, HR Club, Project Management Club, Accounting and Finance Club, and Marketing Club, and the Faculty will take initiatives to materialize them after the normalcy returns.

4. Developing journal publications policy.

The Faculty is of a view to developing "Publications Policy" in the months to come since most of the staff are unaware of finding the credible Journal to get their papers published. Predatory publications are detrimental to academic success, and therefore the Faculty has identified a need to develop a comprehensive mechanism to keep the staff away from publishing their articles in Vanity Press.

5. Faculty Alumni formation.

The Alumni database has been constructed and uploaded in the Faculty website. Around 140 ex-students have registered so far and the constitution got approved in the 449th Council meeting held on 01st November 2020. The Faculty Alumni is labelled as "Alumni Association of the Faculty of Business Studies (AAFBS)", planned to be formed in early 2021.

- 6. Establishing SMART lecture halls are in progress.
- 7. Signing MOUs with internship organizations are in progress.

The students find difficulties searching for an organization that best fits their field of study to follow the internship. The Faculty is aware of it and will soon find a viable solution by way of getting into agreements / increasing collaborations with industries to overcome this issue.

- 8. Establishment of job bank is in progress.
- 9. Introducing a two-year Higher Diploma in English Course.

The Department of English Language Teaching (DELT) has the draft curriculum for the "Higher Diploma in English" yet to be approved. The curriculum would be in line with the requirements as laid down in the Sri Lanka Qualifications Framework - Level 4.

10. Developing Faculty level e-repository

It was planned to create an e-repository to disseminate the Faculty staff and students' research output since repositories are inevitable in the scholarly communication landscape nowadays.

- 11. Introducing subject disciplined Conferences and Journals.
- 12. Increasing publications in Science Indexed Journals.

The Faculty plans to take concrete steps to uplift the quality of research work of the staff and students through workshops, especially on "Academic Writing," paving the way to get their papers published in well-reputed Indexed Journals.

- 13. Obtaining national and international accreditations.
- 14. Research Collaborations with foreign universities.
- 15. Conducting Career Fairs.
- 16. Developing a "Faculty Charter".

13.0 Failures and Achievements

1. Unable to expand infrastructure and academic facilities.

The Faculty is facing issues because of a lack of funds to further expand its infrastructure and academic facilities. The Cabinet approved the construction of a building complex for the Faculty of Business Studies at a total estimated LKR 926 million costs to implement the project phase-wise for three years from 2021. The government suspended the implementation of all new building projects with immediate effect due to the COVID outbreak. It would become difficult for the Faculty to accommodate students in the hostel if the government increases the students' intake in the next Academic Year.

2. Lack of self-generated income activities.

The Faculty is primarily depending on government funding to carry out and sustain its activities. Further, the self-generated income comes from the Industry Community Interaction Cell of the Vavuniya Campus (ICICVC) since no other Master Degree Programmes or extension courses are currently available. It is a timely need to introduce extension courses and expedite the Master's degree programs' curriculum development process. The Faculty is aware of it and has started the preliminary work for introducing MBA and Master of Project Management postgraduate degree programs soon. The Curriculum Development Committee was formed, and the budget also approved by the Council, signaling the Faculty's commitment towards finding alternative sources of income rather than fully depending on government sources of financing.

3. Lack of interaction between the staff and students.

The country's prevailing situation is a hindering factor that has resulted in having less interaction between the staff and students. It limits the Faculty to carry out certain activities such as the formation of Alumni and materializing the student clubs. The Faculty has prepared the constitution for Alumni and the Terms of Reference (TOR) for establishing student clubs, and both got approved by the Council. Nevertheless,

the Faculty is unable to progress further due to the physical absence of students and Alumni.

14.0 Any Other Activities

14.1 Tree Plantation Day



The Faculty Plantation and Beautification Committee has conducted plantation activities from December 5th - 9th, 2020. The Faculty has formally organized the 'Faculty Plantation Day' on 9th December, 2020. The Faculty Plantation was ceremonially started on the auspicious occasion at 9 am in the faculty premises. In total, 100 students and 40 staff members have participated in the plantation activities. The event began with an opening speech by Mrs. S. Mathivathany, Senior Treasurer

of the Faculty Students' Union. Followed by, Dr. Y.Nanthagopan, Dean of the Faculty, delivered the speech and thanked the staff and students to carry out the planting activities of the Faculty successfully. Also, he appreciated Mr. T. Raguram, Curator, for his support rendered to the Faculty.
