01. FACULTY OVERVIEW


1.1 Faculty Overview

The Faculty of Business Studies was established in 1997 under the Vavuniya Campus of the University of Jaffna. During the year 2021, the Vavuniya Campus of the University of Jaffna has been upgraded as the newly incorporated government university and named as University of Vavuniya. The faculty of Business Studies offers BBM honours degree programme; namely, Accounting and Finance, Marketing Management, Business Economics, Human Resource Management, Entrepreneurship, Project Management and Banking and Insurance. Altogether, seven departments function under the faculty. The Department of English Language Teaching has also been part of the Faculty of Business Studies.
